We were selected as one of 8 institutions (out of 16 who submitted proposals) to be a nominating institution. Under this program, selected preservice teachers completing our approved licensure programs at the graduate level would have been eligible for a \$20,000 signing bonus after taking their first job in MA. Unfortunately the MA state legislature withdrew the funding for the signing bonus program in May 2003.
